# The System of Audit Quality Management: Pilots for SAIs

## A call for Expressions of Interest

### **Background and Context**

To build trust, establish credibility and sustain effectiveness of Supreme Audit Institutions (SAIs), there is a need to ensure quality in the audits carried out by the SAI. Quality refers to the degree to which the audits



carried out and the reports issued by the SAI comply with professional standards and applicable legal and regulatory requirements, to help the SAI in fulfilling its mandate and contribute value.

INTOSAI is currently working on revising ISSAI 140 - Quality Management for SAIs, with plans to move towards a holistic and systemic risk-based approach to quality management. INTOSAI Development Initiative (IDI) is writing a playbook to support SAIs in setting up a System of Audit Quality Management (SoAQM). The playbook is aligned to the requirements of draft ISSAI 140.

What is a system which the SAI designs, implements and operates at the organisational level to support the achievement of objectives and to enable the SAI and its personnel to conduct high quality audits, fulfil their responsibilities in accordance with professional standards and applicable legal and regulatory requirements, and contribute value.



**Establishment of quality objectives:** The first step is to establish quality objectives which are tailored to the SAI circumstances.

**Implementation of risk-based approach in managing audit quality:** Based on the established quality objectives, the SAI needs to identify and assess quality risks to build a basis in developing responses to manage those risks. This process enables building a system appropriate to the SAI needs.

**Establishment of a more proactive monitoring and remediation process:** In addition to communication of results of monitoring, the SAI also needs to evaluate findings, perform root cause analysis, and identify and address the deficiencies noted. This enables continuous learning for improving the SoAQM.



In completing the form, SAIs will be requested to prepare reflection on the following areas: Description of the SAI's current SAI willingness SAI's plans SAI readiness practices in managing to commit for setting-up to participate audit quality including required time SoAQM in the pilot what works well and and resources what needs to be improved

#### The IDI will use the following criteria in selecting SAIs:

Completeness and quality of information in the applications SAI readiness to conduct the pilot Regional spread of SAIs SAI's willingness to commit required time and resources
